Bylaw No. 696, 2018

A Bylaw to establish various fees and charges imposed by the Municipality

WHEREAS the Community Charter provides authority for Municipalities to establish various fees and charges, interest and penalties, terms and conditions, discounts and refunds,

AND it is deemed desirable and expedient to establish these fees and charges, interest and penalties, terms and conditions, discounts and refunds in one bylaw;

THEREFORE, The Council of the Corporation of the Village of Lytton in open meeting assembled hereby enacts as follows:

- 1) The Village of Lytton hereby imposes fees for service as specified in Schedules "A" to "E" in this bylaw effective July 1, 2018:
 - a) Schedule "A" - Miscellaneous Fees, Pool Swim Rates, and Equipment Rental Charges
 - b) Schedule "B" - Animal Fees
 - c) Schedule "C" - Cemetery Fees
 - d) Schedule "D" - Water Rates 2017-2019
 - e) Schedule "E" - Sewer Rates 2017-2019

- 2) The Village of Lytton hereby imposes interest charges on Fees and Charges that remain unpaid 30 days following the due date of the invoice, bill, or notice of payment required. Interest so charged will be simple interest.

SEVERABILITY

If at any time, any provision of this bylaw is declared or held to be illegal, invalid, or ultra vires, in whole or in part, then the provision shall not apply and the remainder of this bylaw shall continue in full force and effect and be construed as if it had been enacted without the illegal, invalid, or ultra vires provision.

REPEAL

The Village of Lytton Fees & Charges Bylaw No. 689, 2017 and No. 689-1, 2017 are hereby repealed.

This Bylaw may be cited for all purposes as the "Village of Lytton Fees & Charges Bylaw No. 696, 2018"
